Series of 2009**


AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX HUNDRED SIXTY EIGHT THOUSAND PESOS (P668,000.00) FROM THE ADDITIONAL INTERNAL REVENUE ALLOTMENT FOR THE MONTHS OF JANUARY AND FEBRUARY, THIS YEAR FOR THE TERMINAL LEAVE BENEFITS OF SOTERO RESURRECCION, A RETIRED EMPLOYEE IN THE AMOUNT OF ONE HUNDRED SEVENTY EIGHT THOUSAND PESOS (P178,000.00); OFFICE OF THE SANGGUNIANG BAYAN - FURNITURE AND FIXTURES – TWO HUNDRED NINETY THOUSAND PESOS (P290,000.00) AND OFFICE EQUIPMENT - TWO HUNDRED THOUSAND PESOS (P200,000.00)

WHEREAS, the former Municipal Social Hall is being converted as the Sangguniang Bayan Session Hall that there is a need to provide for the needed furniture and fixtures and office equipment for use by the legislative body considering that those that they are using at present will be for their use also at the Sangguniang Bayan Office;

WHEREAS, Sotero Resurreccion, former Utility Worker had already retired from the service that there is also a need to appropriate funds for his Terminal Leave Benefits;

WHEREAS, there is an increase in the Internal Revenue Allotment for the current year to which the above-stated amount could be derived from;



WHEREFORE, on motion of Hon. Elsie Garces duly seconded by Hon. Samuel Calano, **BE IT ORDAINED THAT:**

Section 1. - The amount of Six Hundred Sixty Eight Thousand Pesos (P668,000.00) is hereby appropriated from the Increase in the Internal Revenue Allotment for the months of January and February, this year for the Terminal Leave Benefits of Sotero Resurreccion- One Hundred Seventy Eight Thousand Pesos (P178,000.00); Office of the Sangguniang Bayan - Furniture and Fixtures - Two Hundred Ninety Thousand Pesos (P290,000.00) and Office Equipment - Two Hundred Thousand Pesos (P200,000.00) .

Section 2. - This ordinance shall take effect upon approval.


