AN ORDINANCE REVERTING THE AMOUNT OF SIX HUNDRED FIFTY THOUSAND PESOS (PHP650,000.00) FROM CAPITAL OUTLAY - LAND TRANSPORT EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIANG BAYAN AND RE-APPROPRIATING SAME UNDER THE OFFICE OF THE MAYOR – OPERATION OF MOTOR POOL, DINGRAS, ILOCOS NORTE.

Section. 1. The amount of Six Hundred Fifty Thousand Pesos (Php650,000.00) from Capital Outlay - Land Transport Equipment under the Office of the Sangguniang Bayan is hereby reverted and re-appropriated under the Office of the Mayor – Operation of Motor Pool, Dingras, Ilocos Norte.

Section 2. That the Office of the Sangguniang Bayan as represented by the Vice Mayor shall be given equal preference for the use of the equipment where the funds will be used.
