AN ORDINANCE REVERTING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP400,000.00) FROM CAPITAL OUTLAY - LAND TRANSPORT EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIANG BAYAN AND RE-APPROPRIATING SAME UNDER THE OFFICE OF THE MAYOR – OPERATION OF MOTOR POOL, DINGRAS, ILOCOS NORTE.

Section 1. The amount of Four Hundred Thousand Pesos (Php400,000.00) from Capital Outlay - Land Transport Equipment under the Office of the Sangguniang Bayan is hereby reverted and re-appropriated under the Office of the Mayor – Operation of Motor Pool, Dingras, Ilocos Norte.

Section 2. That the said amount shall be used exclusively for the purchase of back hoe.


