
AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION SEVEN HUNDRED SEVENTY THREE THOUSAND NINE HUNDRED THIRTY FOUR AND 60/100 PESOS (PHP1,773,934.60) TO PARTIALLY IMPLEMENT THE COMPENSATION OF PUBLIC OFFICIALS AND EMPLOYEES UNDER THE THIRD PHASE SALARY STANDARDIZATION LAW, RETRO-ACTIVE JANUARY 01, 2010 FROM THE INTERNAL REVENUE ALLOTMENT INCREASE FOR 2010 COVERING SUPPLEMENTAL BUDGET NO. 01 OF THE GENERAL FUND FOR CY 2010

WHEREAS, Local Budget Circular No. 2009-92 dated September 3, 2009 provides for the guidelines in the implementation of the first tranche salary schedule of Local Government Personnel and Modified Position Classification System;

WHEREAS, this local government unit had received the amount of Two Million One Hundred Thousand Pesos (Php2.1M) representing the increase in the Internal Revenue Allotment which could be appropriated for the partial implementation of the said salary increase

WHEREAS, the above-stated Local Budget Circular specifically provides that if funds are insufficient to implement fully the Salary schedule for the LGU level and income



Pesos (Php 5,375,000.00) for the continuation of the improvement of Municipal Civic Center: Five Million Pesos (Php 5,000,000.00) for concrete paving of barangay roads (Suyo, Capasan, Bacsil, Espiritu, Foz and Sagpatan); Two Million Fifty Eight Thousand Five Hundred Forty Four and 14/100 (Php 2,058,544.14) for the purchase of cement and Mixed Sand and Gravel (MSG);

Section 2. This ordinance shall take effect upon approval.




