
AN ORDINANCE REVERTING THE AMOUNT OF EIGHTY THOUSAND PESOS (PHP80,000.00) FROM MOOE-OTHER MAINTENANCE AND OPERATING EXPENSE UNDER THE OFFICE OF THE MAYOR AND RE-APPROPRIATING THE SAME FOR FURNITURES AND FIXTURES (CO) – THIRTY THOUSAND PESOS (PHP30,000.00) AND IT EQUIPMENT AND SOFTWARE (CO) – FIFTY THOUSAND PESOS (PHP50,000.00) FOR THE OFFICE OF THE MAYOR, DINGRAS, ILOCOS NORTE

WHEREAS, after a careful study on the request of the Municipal Mayor regarding their Capital Outlay, there is a need to revert the amount of Eighty Thousand Pesos (Php80,000.00) from Other Maintenance and Operating Expense (MOOE) to Furniture and Fixtures – Php30,000.00 and IT Equipment and Software Php50,000.00;

Section 2. This ordinance shall take effect upon approval.




