
MUNICIPAL APPROPRIATION ORDINANCE NO. 2010-08-017
Series of 2010

AN ORDINANCE REVERTING THE AMOUNT OF ONE MILLION THREE HUNDRED TWENTY THREE THOUSAND NINE HUNDRED TWENTY PESOS (PHP1,323,920.00) FROM OTHER PUBLIC INFRASTRUCTURE (CO) UNDER THE OFFICE OF THE MAYOR-OPERATION OF CEMETERY AND RE-APPROPRIATING THE SAME FOR THE IMPROVEMENT OF PARKS, PLAZA & MONUMENTS (MOOE), DINGRAS, ILOCOS NORTE

WHEREAS, after a careful study on the request of the Municipal Mayor regarding their MOOE, there is a need to revert the amount of One Million Three Hundred Twenty Three Thousand Nine Hundred Twenty Pesos (Php1,323,920.00) from Other Public Infrastructure (CO) under the Office of the Mayor-Operation of Cemetery and re-appropriating the same for the improvement of Parks, Plaza & Monuments (MOOE), Dingras, Ilocos Norte;

Section. 1. The amount of One Million Three Hundred Twenty Three Thousand Nine Hundred Twenty Pesos (Php1,323,920.00) from Other Public Infrastructure (CO) under the Office of the Mayor-Operation of Cemetery is hereby re-appropriated the same for the improvement of Parks, Plaza & Monuments (MOOE), Dingras, Ilocos Norte.
