MUNICIPAL APPROPRIATION ORDINANCE NO. 2010-08-025

AN ORDINANCE REALIGNING THE AMOUNT OF TWENTY SEVEN THOUSAND FIVE HUNDRED PESOS (PHP27,500.00) FROM SUPPLIES EXPENSES TO TRAVEL EXPENSES – PHP10,000.00; TRAINING & SEMINAR EXPENSE – PHP10,000.00; MOBILE EXPENSE – PHP3,000.00; MEMBERSHIP DUES & ORG. CONT. – PHP4,500.00 UNDER THE OFFICE OF THE MUNICIPAL TREASURER, DINGRAS, ILOCOS NORTE

WHEREAS, after a careful study on the request of the Municipal Treasurer, there is a need to realign the amount of Twenty Seven Thousand Five Hundred Pesos (Php27,500.00) from Supplies Expenses to Travel Expenses – Php10,000.00; Training & Seminar Expense – Php10,000.00; Mobile Expense – Php3,000.00; Membership Dues & Org. Cont. – Php4,500.00 under the Office of the Municipal Treasurer, Dingras, Ilocos Norte;

Section. 1. The amount of Php5,000.00 – Other Supplies Exp.; Php4,000.00 – Postage and Deliveries; Php5,000.00 – Taxes, Duties & Licenses; Php10,000.00 – Insurance Expenses for a total amount of Php39,000.00 is hereby realigned to Travel Expenses – Php8,000.00; Repair & Maint. – Office Equipmt. – Php5,000.00; Repair & Maint. – Motor Vehicle – Php5,000.00; Other Maint. & Operating Exp.(Election Expenses) – Php21,000.00 under the Office of the Municipal Treasurer, Dingras, Ilocos Norte;




