



AN ORDINANCE REVERTING THE AMOUNT OF NINE THOUSAND PESOS (PHP. 9,000.00) FROM THE CAPITAL OUTLAY – MOTOR VEHICLES UNDER THE SANGGUNIANG BAYAN OFFICE AND RE-APPROPRIATING THE SAME TO CAPITAL OUTLAY - FURNITURES AND FIXTURES OF THE SAME OFFICE.

WHEREAS, the current resources of the Sangguniang Bayan in the items "Furnitures and Fixtures" under the Capital Outlay is not sufficient to finance the program or activity of the same office;

WHEREAS, there is sufficient fund in the amount of Nine Thousand Pesos (Php.9,000.00) from "Motor Vehicles" under the Capital Outlay of the Sangguniang Bayan Office to augment the resources of the abovementioned items;



WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Nathaniel Ruben P. Taylan,

BE IT ORDAINED THAT:

Section 1. The amount of Nine Thousand Pesos (Php. 9,000.00) from the Motor Vehicles under the Capital Outlay is hereby reverted and re-appropriated to Furnitures and Fixtures under the Capital Outlay of the Sangguniang Bayan Office.

Section 5. The legislative tracking unit of the Sangguniang Bayan shall be responsible in tracking and monitoring the implementation by the executive agency/department.






