**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2008-07-026 AS  
AMENDED**

**BE IT ENACTED BY THE SANGGUNIANG BAYAN THAT:**

**WHEREAS**, Section 1 of Municipal Ordinance No. 2008-07-026 series 2008 which reads:

“A regular fare of Nine Pesos (P9.00) for the first kilometer and One Peso (P1.00) for every succeeding kilometer thereafter be charged per passenger and Seven Pesos (P7.00) for the first kilometer and One Peso (P1.00) for every succeeding kilometer for Students and Senior Citizens/Disabled” is hereby amended as follows;

Section 1. A regular fare of **Eight Pesos (P8.00)** for the first kilometer and **One Peso (P1.00)** for every succeeding kilometer thereafter be charged per passenger and **Seven Pesos (P7.00)** for the first kilometer and **One Peso (P1.00)** for every succeeding kilometer for Students and Senior Citizens/Disabled;



Section 2. **REPEALING CLAUSE.** All ordinances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 3. **EFFECTIVITY.** This ordinance shall take effect after its posting for three (3) consecutive weeks in a bulletin board at the entrance of the Municipal Hall and in at least two (2) other conspicuous places within the territorial jurisdiction of the municipality.


