AN ORDINANCE AUTHORIZING THE VICE MAYOR/PRESIDING OFFICER TO AUGMENT ANY ITEM IN THE APPROVED ANNUAL BUDGET SAVINGS UNTIL NOVEMBER 15, 2008 IN OTHER ITEMS WITHIN THE SAME EXPENSE CLASS OF APPROPRIATIONS OF THE SANGGUNIANG BAYAN TO BE ABLE TO FACILITATE THE DELIVERY OF BASIC SERVICES AS PROVIDED UNDER ARTICLE 454 (B) (1) (2) OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

BE IT ENACTED by the Sangguniang Bayan that:

Section 1. The Vice Mayor/Presiding Officer is hereby authorized to augment any item in the Approved Annual Budget from savings until November 15, 2008 in other items within the same expense class of appropriations of the Sangguniang Bayan to be able to facilitate the delivery of basic services as provided under Article 454 (b) (1) (2) of the rules and Regulations Implementing the Local Government Code of 1991.

Section 2. This ordinance shall take effect upon approval.
