AN ORDINANCE AMENDING SECTION 2 ON MUNICIPAL ORDINANCE NO. 2003-05-022 SERIES OF 2003

BE IT ORDAINED THAT:

Section 1. Section 2 of Municipal Ordinance No. 2003-05-022 series of 2003 which reads as:

"This VETERAN'S MEMORIAL PARK shall be for the exclusive use of deceased bona fide veterans duly accredited by the Post Commander of the Dingras Veterans Post, as well as active, integral and organic members of the Armed Forces of the Philippines who die in the line of duty and/or retire members" is hereby amended to:

"This VETERAN'S MEMORIAL PARK shall be for the exclusive use of deceased bona fide veterans duly accredited by the Post Commander of the Dingras Veterans Post, as well as active, integral and organic members of the Armed Forces of the Philippines who die in the line of duty and/or retire members including the legal wife of the bonafide veteran of the Municipality of Dingras."

The term "legal wife" as used in this section shall mean the woman to whom the veteran entered into a Special Contract of permanent union in accordance with law for the establishment of conjugal and family life.

Section 3. **REPEALING CLAUSE**. All ordinances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 4. **EFFECTIVITY**. This ordinance shall take effect after its posting for three (3) consecutive weeks in a bulletin board at the entrance of the Municipal Hall and in at least two (2) other conspicuous places within the territorial jurisdiction of the municipality.
