**AN ORDINANCE REGULATING THE ISSUANCE OF REGULATORY BUSINESS
PLATES TO ALL BUSINESS OPERATORS REGISTERED IN THE MUNICIPALITY
OF DINGRAS, ILOCOS NORTE.**


BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF DINGRAS THAT:

Section 1. All business operators registered in the Municipality of Dingras are required to secure business plates from the Office of the Municipal Treasurer.

Section 2. That the business plates upon issuance of the business permit shall be given as a service instrument of the municipality to the plate holders.

Section 3. Said business plates shall be displayed in front of their respective businesses.

Section 4. Any violation shall be subjected to a fine of One Thousand Pesos (1,000) for the first offense; One Thousand Five Hundred Pesos (1,500) for the second offense; and for the third final offense cancellation of their business permit.



Section 5. This ordinance shall take effect after its posting for 3 consecutive weeks in public places within the territorial jurisdiction of the Municipality of Dingras.
