BE IT ORDAINED THAT:

Section 1. There shall be collected the following fees from every person requesting for copies of official records/documents from the Office of the Municipal Assessor:

Section 2. The fees shall be paid to the Municipal Treasurer at the time the request, written or otherwise for the issuance of the above-documents is made.

Section 3. This ordinance shall take effect upon approval, publication and posting as required under Section 59 of R.A. 7160.




