**AN ORDINANCE PRESCRIBING THE USE OF THE ORDINANCE VIOLATION
CITATION TICKET**


WHEREAS, Article 100 of the Rules and Regulations Implementing the Local Government Code of 1991 authorizes the control of different laws and implementing penalties of the different laws vested by the sangguniang bayan;

WHEREAS, there is a need to provide supporting documents for apprehending violators of the different ordinances approved in the municipality;

WHEREFORE, on motion of Hon. Samuel N. Demandante duly seconded by Hon. Joey S. Apostol, **BE IT ORDAINED THAT:**

Section 1. That for every violation of Municipal Ordinances, an Ordinance Violation Citation Ticket shall be issued by the apprehending officer.

Section 2. That the basis of the Municipal Treasurer for the collection of penalties will be the Ordinance Violation Citation Ticket.



Section 3. That the Ordinance Violation Citation Ticket will be the evidence in filing a case against violators of any approved ordinances of the Municipality of Dingras to the proper court.

Section 4. This ordinance shall take effect upon approval, publication and posting as required under Section 59 of R.A. 7160.
