**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2009-07-064 SERIES  
OF 2009**

**BE IT ENACTED THAT:**

Section 1. Municipal Ordinance No. 2009-07-064 regulating the issuance of regulatory business plates to all business operators registered in the Municipality of Dingras, Ilocos Norte is hereby amended to insert additional provisions to read as follows:

*"Section 2. The size of the business plates shall be 4.5 x 10 inches for the bigger plates and 3.0 x 7 inches for the smaller plates and with the corresponding plate charges of Three Hundred (Php300.00) and Two Hundred Fifty Pesos (Php250.00) respectively."*

*"Section 3. The business plates upon issuance of the business permit shall be given as a service instrument of the municipality to the plate holders."*



Section 2. All ordinances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 3. This ordinance shall take effect after its posting for 3 consecutive weeks in public places within the territorial jurisdiction of the Municipality of Dingras.


