

**AN ORDINANCE DECLARING THAT THE ISSUANCE OF ALL CIVIL REGISTRY
CERTIFICATIONS EXCEPT MARRIAGE LICENSE WILL BE FREE OF CHARGE IN
THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE ON FEBRUARY 27 OF EVERY
YEAR PURSUANT TO PROCLAMATION NUMBER 682**

BE IT ENACTED THAT:

WHEREAS, Proclamation No. 682 dated January 28, 1991 was issued declaring
February Of every year as Civil Registration month;

WHEREAS, the observance of Civil Registration Month will remind the citizens of their
duties to register acts and events concerning the status of persons to enhance
nationwide awareness of statistical values of civil registry documents;



WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Elsie P. Garces, **BE IT ORDAINED THAT:**

Section 1 - The issuance of all Civil Registry Certifications except Marriage License will be free of charge in the municipality of Dingras, Ilocos Norte on February 27 of every year pursuant to proclamation number 682.

Section 2 - That if February 27 falls on a Saturday, Sunday or holiday, the issuance of Civil Registry Certifications free of charge subject of this ordinance shall be availed of on the working day preceding February 27.

Section 3. - This ordinance shall take effect upon approval.
