Series of 2010**

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2010-07-076 SERIES OF 2010 ENTITLED "AN ORDINANCE PRESCRIBING THE USE OF THE MUNICIPAL CIVIC CENTER AND STALLS TO PROMOTE ECONOMIC GROWTH AND TOURISM WITH CORRESPONDING RENTAL"



BE IT ORDAINED THAT:

Section 2. - That the use of Civic Center will be permitted by securing mayor's permit to conduct activities by paying considerable maintenance fee of Sixty Pesos (Php60.00) per hour from 7:00 A.M. to 5:00 P.M. and One Hundred Pesos (Php100.00) per hour from 5:00 P.M. to 6:00 A.M. inclusive electricity is hereby amended and read as follows:

"Section 2. That the use of the Civic Center will be permitted only after securing Special Permit duly approved by the Local Chief executive or her duly authorized representative and by paying a maintenance fee of Php1,000.00 for the first hour and Php100.00 for the succeeding hours inclusive of electricity.

Section 3. - That the use of the stalls surrounding the facility for economic and tourism promotion enterprise will be paying considerable amount of Two Pesos (Php 2.00) per square meter per day is hereby amended as follows:

"Section 3. That the use of the stalls surrounding the facility is intended for the promotion of economic and tourism enterprise with a corresponding rental fee of Php1,000.00 per month.



Section 4. - That the Local chief Executive is authorized to enter into a Contract of Lease to the qualified stall holders.

Section 5. - This ordinance shall take effect upon approval.
