**AN ORDINANCE PRESCRIBING THE USE OF THE MUNICIPAL CIVIC CENTER  
AND STALLS TO PROMOTE ECONOMIC GROWTH AND TOURISM WITH  
CORRESPONDING RENTAL**


**WHEREAS**, Section 18 of the Local Government Code clearly defines the function of the Local Government Unit to generate and apply resources ;

**WHEREAS**, the Municipal Civic Center which is being developed is a clear show window of economic and tourism development of the municipality which could generate enough resources for its operation;

**WHEREFORE**, on motion of Hon. Joey S. Apostol duly seconded by Hon. Rhandolf P. Magno , **BE IT ORDAINED THAT:**

Section 1. – That the use of the center and its stalls for the purpose of public and private activities of the municipality should be permitted and allowed by the municipal government.

Section 2. - That the use of Civic Center will be permitted only after securing Special Permit to duly approved by the Local Chief Executive of her duly authorized representative and by paying a maintenance fee of Php1,000.00 for the first hour and Php100.00 for the succeeding hours inclusive of electricity.



Section 3. – That the use of stalls surrounding the facility is intended for the promotion of economic and tourism enterprise with a corresponding rental fee of Php1,000.00 per month.

Section 4. - That the Local chief Executive is hereby authorized to enter into a Contract of Lease to the qualified holders.

Section 5. - This ordinance shall take effect upon approval.




