MARCELINO NATIONAL HIGH SCHOOL**



WHEREAS, the Department of Education, Regional Office I approved the request for the separation of Dingras National High School/Lt. Edgar Foz Memorial National High School-San Marcelino campus from its mother school Dingras National High School/Lt. Edgar Foz Memorial National High School-Poblacion campus, Dingras, Ilocos Norte effective School Year 2010-2011;

WHEREAS, renaming of school is governed by DECS Memorandum No. 386, s. 1999 under RA 7160 otherwise known as the Local Government Code of 1991, the Local School Board can recommend to the Local Sanggunian the change of name of the school, the Local Sanggunian which has the power to change the name of school, then enacts an ordinance;

WHEREAS, the Municipal School Board interposes no objection on the renaming /of Dingras National High School/Lt. Edgar Foz Memorial National High School, San Marcelino campus as San Marcelino National High School;

WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Robert V. Parado, BE IT ORDAINED THAT:



Section 1. That Dingras National High School/Lt. Edgar Foz Memorial National High School-San Marcelino campus is hereby renamed as San Marcelino National High School.

Section 2. This Ordinance shall take effect upon approval and posting as required under Section 59 of R.A. 7160.


