**AN ORDINANCE PRESCRIBING THE RULES AND REGULATIONS IN THE  
PROPER MAINTENANCE OF PUBLIC COMFORT ROOMS/BATHROOMS  
LOCATED AT THE MUNICIPAL PUBLIC MARKET, DINGRAS, ILOCOS NORTE**


**BE IT ORDAINED THAT:**

Section 1. Definition of terms:

1. Vandalism – destruction or defamation of public property  
- destruction caused by a vandal
2. Penalty – something, especially a sum of money required as a forfeit for  
an offense.
3. Maintenance – the process of keeping something in good condition

Section 2. Maintenance fee shall be paid for every use of the comfort rooms/bathrooms  
located at the Municipal Public Market.

Section 3. Vandalism is prohibited inside and in the surrounding of the service  
facility



Section 4. Collection ticket will be issued to the user as proof of payment after using the facility.

Section 5. The current rates of fees for the following purposes shall be:

Section 6. Penalty for every violation shall be Five Hundred Pesos (Php500.00).

Section 7. All collections on fees and penalties shall be deposited everyday in the Municipal Treasurer's Office as Trust Fund for the maintenance of the said facilities.

Section 8. This ordinance shall take effect upon approval, publication and posting as required under Section 59 of R.A. 7160.


