

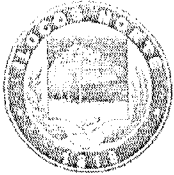

FINDINGS/OBSERVATIONS

The subject ordinance has as basis Section 13 of RA 7160, giving the concerned LGU the power to name public places within its territorial jurisdiction.
