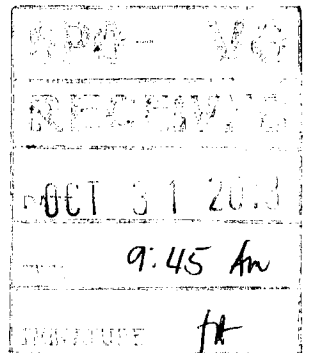

RE: Municipal Ordinance No. 2013-09-007 Series of 2013 of Dingras, Ilocos Norte --“AN ORDINANCE AMENDING SECTION 15 (PROCEDURE FOR THE ISSUANCE AND RENEWAL OF FRANCHISE) OF MUNICIPAL ORDINANCE NO. 2010-08-004, SERIES OF 2010 OTHERWISE KNOWN AS THE “FRANCHISE ORDINANCE””

FINDINGS & OBSERVATION:

1. That Pursuant to the provisions of Republic Act 7160, Book III, Title Two, Article III Section 447 (3) (vi) to wit:

Section (3) (vi). “Subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality”;

2. That a certification issued by SB Secretary Lydia A. Aquino, certifying the conduct of a public hearing and said certification was issued on the 17th day of October 2013;



AN ORDINANCE AMENDING SECTION 24 (FARE GUIDE PROVISION) AND SECTION 15 (PROCEDURE FOR THE ISSUANCE AND RENEWAL OF FRANCHISE) OF MUNICIPAL ORDINANCE NO. 2010-08-004, SERIES OF 2010 OTHERWISE KNOWN AS THE "FRANCHISE ORDINANCE"

BE IT ENACTED by the Sangguniang Bayan that:



WHEREAS, Section 24 of the Municipal Ordinance No. 2010-08-004 series of 2010 which read as follows:

"A Regular fee of eight pesos (8.00) for the first km and One peso (1.00) for every succeeding kilometer thereafter be charged per passenger and seven pesos (7.00) for the first KM. and one peso (1.00) for every succeeding km. for students and Senior citizen/disabled" is hereby amended as follows:

Section 1. Fare Guide. A regular fee of ten Pesos (P10.00) for the first kilometer and One Peso (P1.00) for every succeeding kilometer thereafter be charged per passenger and eight Pesos (P8.00) for the first kilometer and one peso (P1.00) for every succeeding kilometer for students and senior citizen/disabled.

Section 2. Section 15 (a), Procedure for the issuance and renewal of franchise, which read as follows: "The applicant shall accomplish the application for renewal which shall be in the form prescribed herein" is hereby amended as follows:

a. The applicant shall accomplish the application for the issuance and renewal of franchise after the unit has been presented for inspection.



Section 3. Repealing Clause. All ordinances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect after its posting for three (3) consecutive weeks in a bulletin board at the entrance of the Municipal Hall and in at least two (2) other conspicuous places within the territorial jurisdiction of the municipality.
