

RE: *Municipal Ordinance no. 2013 – 09 - 011 – " An ordinance amending Chapter IV, Article A, Section 4A.03A of Municipal Ordinance no. 2010 – 08 – 003 Series of 2010 , otherwise known as the Market Code of the Municipality of Dingras, Ilocos Norte".*

FINDINGS & OBSERVATIONS:

The Committee on Market and Slaughterhouse hereby endorses the findings and observations of the Provincial Finance Committee, thus;

1. That the ordinance is within the authority of the Sangguniang Bayan as provided for under Section 447(3).(i) of the Local Government Code of 1991 and is not in violation of the provision of Section 191 of the Code as the amendment is a downward adjustment of rates wherein the opinion of Atty. Sofronio B. Ursal as written on his book , Philippine Law on Government Taxation relative with the latter section afore – mentioned, to quote:


The extent of the authority of local units to adjust tax rates.

However local governments may, at anytime thru ordinance adjust downwards the rates of existing tax, fee or charge or even abolish altogether, x-x-x-"

Section 447(3)(i) and Section 191 of the Local Government Code of 1991:

3) Subject to the provisions of Book II of this Code, grant franchises, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality, and pursuant to this legislative authority shall:



(i) Fix and impose reasonable fees and charges for all services rendered by the municipal government to private persons or entities

Section 191. Authority of Local Government Units to Adjust Rates of Tax Ordinances. - Local government units shall have the authority to adjust the tax rates as prescribed herein not oftener than once every five (5) years, but in no case shall such adjustment exceed ten percent (10%) of the rates fixed under this Code.


2. That the provision of Section 187 has been complied with as evidenced by the certification that is attached.

Section 187. Procedure for Approval and Effectivity of Tax, Ordinances and Revenue Measures; Mandatory Public Hearings. - The procedure for approval of local tax ordinances and revenue measures shall be in accordance with the provisions of this Code: Provided, That public hearings shall be conducted for the purpose prior to the enactment thereof: Provided, further, That any question on the constitutionality or legality of tax ordinances or revenue measures may be raised on appeal within thirty (30) days from the effectivity thereof to the Secretary of Justice who shall render a decision within sixty (60) days from the date of receipt of the appeal: Provided, however, That such appeal shall not have the effect of suspending the effectivity of the ordinance and the accrual and payment of the tax, fee, or charge levied therein: Provided, finally, That within thirty (30) days after receipt of the decision or the lapse of the sixty-day period without the Secretary of Justice acting upon the appeal, the aggrieved party may file appropriate proceedings with a court of competent jurisdiction.

RECOMMENDATION:

The Committee therefore recommend that Municipal Ordinance no. 2013 – 09 - 011 of the Municipality of Dingras be declared **VALID**.

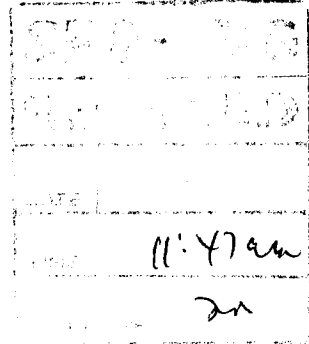





**MUNICIPAL ORDINANCE NO. 2013-09-011
Series of 2013**

**AN ORDINANCE AMENDING CHAPTER IV, ARTICLE A, SECTION 4A.03A OF MUNICIPAL
ORDINANCE NO. 2010-08-003 SERIES OF 2010, OTHERWISE KNOWN AS THE MARKET
CODE OF THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE.**

BE IT ORDAINED THAT:

CHAPTER IV –Market and Slaughterhouse fees and charges, Article A – Market fees and charges, Section 4A.03-Imposition of Market Fees and charges which states that:

“There shall be collected the following Market fees and charges :

- A. Rental charges on stalls, booth, and/or spaces within the market building shall be P5.00 per sq. meter per day excluding meat and fish section in accordance with the existing Municipal Ordinance.”*

Is hereby amended to read as follows:

- A. Rental charges on stalls, booth, and/or spaces within the market building shall be P4.00 for the whole year of 2014, and year after 2014 will be total implementation of the Market Code provision on Imposition of Market Fees and Charges, which is P5.00 per sq. meter.**



Section 3. This ordinance shall take effect upon approval.




