

RE: *Municipal Ordinance no. 2014-09-015 - " An ordinance prescribing fees, rules and regulations governing the operation of the Municipal I - Hub in the Municipality of Dingras, Ilocos Norte."*

FINDINGS & OBSERVATIONS:

The Committee on Ways and Means hereby endorses the findings and observations of the Provincial Finance Committee, thus:

1. That, pursuant to Sec. 447 par.2(ii) and 3(i) of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes:

Section 447. Powers, Duties, Functions and Compensation. -

2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the municipality as provided for under Section 18 of this Code with particular attention to agro-industrial development and countryside growth and progress, and relative thereto, shall:


(ii) Subject to the provisions of Book II of this Code and applicable laws and upon the majority vote of all the members of the sangguniang bayan, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs:

(3) Subject to the provisions of Book II of this Code, grant franchises, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality, and pursuant to this legislative authority shall:

(i) Fix and impose reasonable fees and charges for all services rendered by the municipal government to private persons or entities.

2. That local government units shall discharge other functions and responsibilities as are necessary , appropriate, or incidental to efficient and effective provisions of basic services and facilities;
3. That one of major responsibilities of a municipality as provided for under Sec. 17 (b) par. 2(v) is to provide " information services which include investments and job placement information systems, tax and marketing information systems, and maintenance of a public library.":
4. That said Municipal I – Hub must not be limited to pupils and students only but must be availed also by other researchers who would like to patronize the state of the art innovations a the I – Hub;
5. That the use of the internet services of the Municipal I – Hub shall be solely for research and other legal purposes, in conformity with Sec. 4 of Provincial Ordinance No. 2011 – 004 of the Provincial Government of Ilocos Norte who spearheaded the Sirib Mile Project;
6. That the proof of compliance with the mandatory public hearing as provided for under section 187 of the Code must be submitted;

Section 187. *Procedure for Approval and Effectivity of Tax, Ordinances and Revenue Measures; Mandatory Public Hearings. - The procedure for approval of local tax ordinances and revenue measures shall be in accordance with the provisions of this Code: Provided, That public hearings shall be conducted for the purpose prior to the enactment thereof: Provided, further, That any question on the constitutionality or legality of tax ordinances or revenue measures may be raised on appeal within thirty (30) days from the effectivity thereof to the Secretary of Justice who shall render a decision within sixty (60) days from the date of receipt of the appeal: Provided, however, That such appeal shall not have the effect of suspending the effectivity of the ordinance and the accrual and payment of the tax, fee, or charge levied therein: Provided, finally, That within thirty (30) days after receipt of the decision or the lapse of the sixty-day period without the Secretary of Justice acting upon the appeal. the aggrieved party may file appropriate proceedings with a court of competent jurisdiction.*



7. That the posting requirement required under Section 188 of the Code shall be complied with before the effectivity of the ordinance.

Section 188. Publication of Tax ordinances and Revenue Measures. - *Within ten (10) days after their approval, certified true copies of all provincial, city, and municipal tax ordinances or revenue measures shall be published in full for three (3) consecutive days in a newspaper of local circulation: Provided, however, That in provinces, cities and municipalities where there are no newspapers of local circulation, the same may be posted in at least two (2) conspicuous and publicly accessible places.*

RECOMMENDATION:

The Committee therefore recommend that Municipal Ordinance no. 2014 – 09-015 of the Municipality of Dingras , be declared **VALID provided that adjustments be made.**



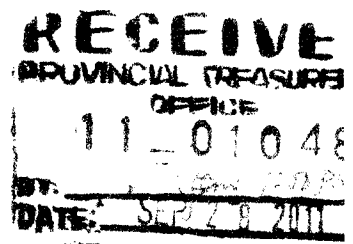

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE A, SECTION
104 OF PROVINCIAL TAX ORDINANCE NO. 2008-001, LOWERING
THE FEES FOR PRINTOUTS AND THE USE OF
COMPUTERS/INTERNET AT THE ILOCOS NORTE PROVINCIAL
LIBRARY *i-hub*

WHEREAS, in order to address the cravings of students and various researchers
in the province, there is a need to install several internet computers at the Ilocos Norte
Provincial Library "*i-hub*"

WHEREAS, there is a corresponding need to prescribe minimal fees for the use
of these internet based computers in line with the economic enterprise thrust of the
Provincial Government

WHEREAS, internet fees shall be lower than the prevailing rate within the radius
of the Provincial Center as an indirect means of helping underprivileged students and
other researchers and to encourage them and other researchers to patronize the state
of the art innovations at the *i-hub*;

NOW, THEREFORE, Be it Ordained that

Section 1. Provincial Ordinance No. 2008-001, more particularly Section 104 thereof which provides, thus:

Section 104. The province hereby charges a Certification Fee for every typewritten, printed or Xerox copy (photocopy) of any official record, document or certification issued by any office or department in the Provincial Government as follows:

Library Internet Fee	- 25.00/hour
Printout	- 5.00/page

x x x "

is hereby amended to read as follows:

"Section 104. The province hereby charges a Certification Fee for every typewritten, printed or Xerox copy (photocopy) of any official record, document or certification issued by any office or department in the Provincial Government as follows:

x x x

Library Internet Fee	- 7.00/hour
Printout	- 1.00/page

x x x "

Section 2. Should the internet fees being charged by establishments offering internet services within a radius of two hundred (200) meters from the Provincial Center average fifteen pesos (Php15.00) per hour or more, the library internet fee that shall be charged at the Ilocos Norte Provincial Library "i-hub" shall be that rate per hour which is fifty percent (50%) lower than the said average internet fees per hour being charged by the said establishments.

Section 3. The library internet fee shall be collected per hour regardless on whether or not the researcher utilized the internet services of the "i-hub" and any fraction of an hour shall be considered as one hour.

Section 4. The use of the internet services of the "i-hub" shall be solely for research and other legal purposes.

Section 5. This Ordinance shall take effect immediately upon its approval subject to the required posting and/or publication as provided for in Section 188 of R.A. 7160 – The Local Government Code of 1991.

**AN ORDINANCE PRESCRIBING FEES, RULES AND REGULATIONS GOVERNING
THE OPERATION OF THE MUNICIPAL I-HUB IN THE MUNICIPALITY OF DINGRAS,

WHEREAS, Section 16 and 17 of the Local Government Code defines the services and benefits that the local government will extend to its constituents;

WHEREAS, the I-Hub is part of the Sirib Mile project which was spearheaded by the Provincial Government of Ilocos Norte;

WHEREAS, the Municipality of Dingras, Ilocos Norte is one of the privileged recipient of this project;



WHEREAS, this project caters, at a lesser cost, to library and IT needs of pupils and students and acts as an imperative factor to promote quality and excellent education;

WHEREAS, there is a need to prescribe fees, rules and regulations governing the operation of the municipal I-Hub;

WHEREFORE, on motion of Hon. Lester S. Ballesteros duly seconded by Hon. Ruben C. Marcos, **BE IT ORDAINED THAT:**

Section 1. There shall be collected fees for the following computer services to wit:

Computer Rental	P5.00/hour
Printing	P1.00/page
CD Burning	P5.00



Section 2. The fees will be collected after use where a system generated receipt indicating the work station number, corresponding service rendered, time of start and end of usage, and amount paid.

Section 3. People with unruly behavior will be banned from entering the establishment.

Section 4. That the operation of the I-Hub will be 8:00 to 6:00 P.M., Monday to Friday and 8:00 to 5:00 P.M. on Saturday.

Section 5. That the municipality shall create Trust Fund account where the fees collected will be deposited and will be used mainly for the maintenance of the I-Hub.

Section 6. This ordinance shall take effect upon approval, publication and posting as required under Section 59 of R.A. 7160.




