**MUNICIPAL ORDINANCE NO. 2014-09-016
Series of 2014**

**AN ORDINANCE TO PROMOTE THE DEVELOPMENT OF THE FARMERS IN THE
VIRGINIA AND BURLEY TOBACCO-PRODUCING BARANGAYS IN THE
MUNICIPALITY OF DINGRAS, ILOCOS NORTE**

Sponsor: Hon. Samuel N. Demandante and the Committee on Agriculture

WHEREAS, it is the policy of the government to extend special support to the farmers of the Virginia and Burley tobacco-producing provinces for developmental projects to be implemented by the local governments of the provinces concerned;

WHEREAS, the Municipality of Dingras, Ilocos Norte regularly receiving share from the excise tax on tobacco products, specifically R.A. 7171 and R.A. 8240;

WHEREAS, there is a need to provide farm input for the development of alternative farming system and to enhance farmer's income;

WHEREFORE, on motion of Hon. Samuel N. Demandante duly seconded by Hon. Joey S. Apostol, **BE IT ORDAINED THAT:**

ARTICLE 1. DEFINITION OF TERMS

- a.) **RA 7171** – an act to promote the development of the farmers in the Virginia tobacco-producing provinces
- b.) **RA 8240** – an act amending sections 138, 139 and 140 of the National Internal Revenue Code, as amended, and for other purposes.

ARTICLE II. GUIDELINES

Section 1. The Municipal Government will be granting subsidy to Virginia and Burley tobacco-producing farmers, apportioning the share of the municipality from the excise tax

of tobacco products, in which the 15% of RA 7171 and 50% of RA 8240 shall be shared for the provision of fertilizer and pesticides to enhance better crop production.

Section 2. That the subsidy will be in form of fertilizer and insecticide assistance.

Section 3. That there should be a committee responsible for creating the implementing guidelines and its proper implementation composed of the following:

- Chairman: Municipal Mayor
- Vice Chairman: Vice Mayor
- Members: Chairman of the Committee on Finance
- Chairman of the Committee on Appropriations
- Chairman of the Committee on Rules and Laws
- Chairman of the Committee on Social Services
- Chairman of the Committee on Barangay Affairs
- Municipal Agricultural Officer
- Local Finance Committee
- NTA Representative
- Chairman of MAFC
- President of Dingras Tobacco Growers Association

ARTICLA III. EFFECTIVITY

Section 1. This ordinance will be effective upon approval which will start for the cropping year 2015.


