WHEREAS, the contracts entered into by and between the Local Chief Executive and the Day Care Workers of this municipality will expire on December 31, 2012;

WHEREAS, said Day Care Workers have always been rendering unselfish and dedicated services to the pre-schoolers, hence, it is fitting and proper that their services be extended in recognition of their sacrifices;

WHEREAS, in cognizance of their unselfish and dedicated services, funds for their monthly honorarium is being appropriated in the LGU's Annual Budget

RESOLVED, as it is hereby resolved to authorize the Local Chief Executive to enter into contract with the Day Care Workers of Dingras, Ilocos Norte;


RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.
