WHEREAS, the Municipal Government of Dingras, Ilocos Norte is maintaining different bank accounts with different banking institutions;




WHEREAS, the banks upon approved closure should provide the Municipal Government a certified true copy of the account transactions from its opening up to the closure for reference and guidance;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.






