A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ERDIO E. VALENZUELA, TO ENGAGE THE SERVICES OF A LEGAL COUNSEL IN ORDER TO PROTECT THE TERRITORIAL JURISDICTIONS OF THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE AGAINST ALL ITS BOUNDARY DISPUTES

WHEREAS, the Municipality of Dingras, Ilocos Norte has several boundary disputes which threatens to loss some of its territory;

WHEREAS, particularly, the Municipality of Dingras, Ilocos Norte has boundary disputes against the Municipality of Sarrat, Municipality of Solsona, Municipality of Marcos, all in Ilocos Norte;


WHEREAS, the Municipality of Dingras, Ilocos Norte must protect its territorial integrity against any claims;


WHEREAS, there is a need to authorize the Honorable Mayor, as provided by the Local Government Code, to engage the expertise of a lawyer in order to protect its territorial jurisdiction and integrity;

WHEREAS, updated accomplishment report shall be submitted by the hired lawyer to the Local Chief Executive and the Office of the Sangguniang Bayan to be regularly reported by the Chairman of the Committee on Rules and Laws in an appropriate session;

WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Samuel Demandante, it was

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Erdio E. Valenzuela, to engage the services of a legal counsel in order to protect the territorial jurisdictions of the Municipality of Dingras, Ilocos Norte against all its boundary disputes.





RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


