
WHEREAS, the lump sum appropriation which the Program Projects and Activities will be approved by the Municipal Development Council;


WHEREAS, revision of the projects program and activities after which being performed and the amount in excess will be reverted to the same field and re-appropriated by MDC EX-COM;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


