No. 5. Committee on Agriculture, Agrarian Reform, Cooperative, and Livelihood; Landed Estates and Assessments.



**WHEREFORE**, on motion of Hon. Joey S. Apostol duly seconded by Hon. Ruben C. Marcos, it was




