**WHEREAS**, the 9<sup>th</sup> Sangguniang Bayan have deliberated properly the proposed investment program and it was in consonance with the provision of law;



**WHEREFORE**, on motion of Hon. Samuel N. Demandante duly seconded by Hon. Joey S. Apostol, it was

**RESOLVED FINALLY**, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.




