**WHEREAS**, the Municipal Disaster Risk Management Plan will be funded under the Calamity Fund;




**WHEREAS**, the members of the Sangguniang Bayan have revisited the MDC resolution and finds it in accordance to law;

**RESOLVED FINALLY**, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.






