**WHEREAS**, the 2014 Annual Budget and 20% Development Plan shows substantial compliance with the same law and its implementing Rules and Regulations;


**WHEREFORE**, on motion of Hon. Samuel Demandante duly seconded by Hon. Joey S. Apostol;
