A RESOLUTION RESPECTFULLY AND EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON AQUINO III, PRESIDENT, REPUBLIC OF THE PHILIPPINES, THROUGH THE EXECUTIVE SECRETARY, HON. PAQUITO OCHOA, JR., TO EXTEND A GRANT IN FAVOR OF THE MUNICIPAL GOVERNMENT OF DINGRAS, ILOCOS NORTE, IN THE AMOUNT OF TEN MILLION PESOS (PHP 10,000,000.00), FOR THE STREET LIGHTING PROJECT ALONG THE NATIONAL HIGHWAY OF THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE.

WHEREAS, one of the program thrust and policies of the Municipal Government of Dingras, Ilocos Norte is to provide a well-lighted streets along the national highway in our jurisdiction in order to safety and comfort to the people;

WHEREAS, street lights does not only provide comfort to people but also to drivers, as accidents can be prevented if the streets are well-lighted with street lights;




Paquito Ochoa, Jr., to extend a grant in favor of the Municipal Government of Dingras, Ilocos Norte, in the amount of Ten Million Pesos (Php 10,000,000.00), for the street lighting project along the National Highway of the Municipality of Dingras, Ilocos Norte.

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to the Office of the President and other authorities concerned for their favorable consideration and approval.


