WHEREAS, the municipality has an old Real Property Tax System which facilitate easy assessment and appraisal of real property;


WHEREAS, said system needs to be updated and upgraded to improve its capabilities, thereby giving more effective and efficient services to our constituents;



RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


