A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ERDIO E. VALENZUELA, TO ENTER INTO A MEMORANDUM OF AGREEMENT, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF DINGRAS, ILOCOS NORTE, WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE NO.1, FOR THE IMPLEMENTATION OF DOLE INTEGRATED LIVELIHOOD PROGRAM (DILP) – NEGO-KART PROJECT (NEGOSYO SA KARITON) IN THE MUNICIPALITY.

WHEREAS, Sec. 16 of the Local Government Code defines the services of local government to its constituents;


WHEREAS, Sec. 22 (c) defines the power of the Sangguniang Bayan to legalize the authority of the Local Chief Executive to enter into whatever contract concerning the local government unit;

WHEREAS, the DOLE implements the program: DOLE Integrated Livelihood Program (DILP) pursuant to Department Order No. 36-02 in line with its effort to help workers and the private enterprise adjust to the growing competitive environment and in accordance with the accounting and auditing guidelines on the release of fund assistance to Non-Government Organization/People's Organization prescribed in COA Circular 2007-01;

WHEREAS, this Municipality has been accredited by DOLE to be capable and experienced in implementing the DOLE Integrated Livelihood Program (DILP) particularly on Nego-Kart Project (Negosyo sa Kariton) and has met all the requirements for accreditation in accordance with COA Circular 2007-01;

WHEREAS, the DOLE shall provide technical as well as fund assistance in the form of training, raw materials, equipment, tools and jigs and working capital;

WHEREAS, the Municipality shall provide equity of at least 20% of the total project cost approved by DOLE;



WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Ruben C. Marcos, it was

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Erdio E. Valenzuela, to enter into a Memorandum Of Agreement, for and in behalf of the Municipal Government of Dingras, Ilocos Norte, with the Department of Labor and Employment – Regional Office No.1, for the implementation of DOLE Integrated Livelihood Program (DILP) – Nego-Kart Project (Negosyo sa Kariton) in the Municipality;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


