WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its implementing Rules and Regulations;



WHEREFORE, on motion of Hon. Samuel N. Demandante duly seconded by Hon. Joey S. Apostol;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to the concerned Barangay.








