WHEREAS, the 2014 Annual Budget and 20% Development Plan shows substantial compliance with the same law and its implementing Rules and Regulations;



WHEREFORE, on motion of Hon. Samuel N. Demandante duly seconded by Hon. Hon. Enrique J. Cañete Jr.;


