A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HON. JOSEPH EMILIO ABAYA, SECRETARY OF THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS, TO ESTABLISH A LAND TRANSPORTATION OFFICE (LTO) SUB-OFFICE IN THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE.


WHEREAS, the Municipality of Dingras, Ilocos Norte is very much aware and concerned to the promotion of safety of land travel;

WHEREAS, the effective and efficient system of registration and operation of motor vehicles, including the licensing owners, dealers, conductors, drivers, and other similar matters are factors in the promotion of the abovementioned vision or purpose;

WHEREAS, there are three existing Land Transportation Offices in the Province of Ilocos Norte, which are: 1. Batac City Office, which serves the municipalities located in the southern part; 2. Municipality of Burgos Office, which serves the municipalities located in the northern part; and the Laoag City Office, which serves as the central office in Ilocos Norte;

WHEREAS, the constituents in the eastern part of Ilocos Norte desire to have a conveniently nearer LTO Sub-Office, as the existing offices of the LTO in the Province are somehow distant;

WHEREAS, the establishment of a nearer LTO Sub-Office in the eastern part is also a way to unclog the works of the LTO Laoag City Office, considering the fact that the number of land vehicles is fast growing;



WHEREAS, the Municipality of Dingras is considered as a hub in the eastern part of the Province of Ilocos Norte;

WHEREAS, the Municipality of Dingras, Ilocos Norte is also regarded as the most convenient and efficient strategic place for the establishment of a LTO Office in order to serve the municipalities located in the eastern part of Ilocos Norte, particularly, the Municipalities of Marcos, Banna, Nueva Era, Solsona, Piddig, and Sarrat;

NOW THEREFORE, Be it Resolved, as it is hereby Resolved, to earnestly and respectfully request Hon. Joseph Emilio Abaya, Secretary of the Department of Transportation and Communication, to establish a Land Transportation Office Sub-Office in the Municipality of Dingras, Ilocos Norte.;

RESOLVED FURTHER, to transmit a copy of this Resolution to Department of Transportation and Communications and concerned offices and agencies for their information and favorable consideration.


