
**WHEREAS**, the preservation and development of culture and arts are imperative factors in the pursuit of economic prosperity and national unity;

**RESOLVED FINALLY**, to request for the assistance and cooperation of the National Commission for Culture and Arts for the realization of the abovementioned purpose.


