A RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (MDC-EXCOM) RESOLUTION NO. 2-2014 RE: REALIGNING THE AMOUNT OF THREE HUNDRED THIRTY TWO THOUSAND ONE HUNDRED THIRTY TWO PESOS & 36/100 CENTAVOS ONLY (P332,132.36) FROM THE 20% MDF CONTINUING UNDER THE SOCIAL SERVICES & ECONOMIC SERVICES INTENDED FOR THE IMPROVEMENT OF THE TOBACCO FARMERS TRADING CENTER AND MULTI-PURPOSE BUILDING (PHP 200,000.00) AND THE TOURISM (PHP132,132.36) OF THE MUNICIPALITY OF DINGRAS.


