

WHEREAS, the organization of the Dingrenios of Hawaii intends to construct a Multi-Purpose Hall for the use and benefit of the people of Dingras;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concern for their information.




