WHEREAS, the 2015 Annual Budget and 20% Development Plan shows substantial compliance with the same law and its implementing Rules and Regulations;


WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Enrique J. Cañete Jr.,

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to the concerned Barangay.








