**WHEREAS**, much to the desire of this local government unit to purchase the said much-needed vehicle, it could not do so due to financial constraint;




**WHEREFORE**, on motion of Hon. Joey S. Apostol duly seconded by Hon. Benigno B. De La Cruz, it was




