WHEREAS, the 2015 Annual Budget and 20% Development Plan shows substantial compliance with the same law and its implementing Rules and Regulations;



WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Alfe Garry R. Gamboa;
