**WHEREAS**, the Municipality of Dingras is a Local Government Unit that regularly supports and implements culture and arts program for the benefit of its constituencies;



**WHEREAS**, the Municipality of Dingras can ensure and encourage the continuing and balanced development of culture by the people themselves;




