MARCOS, IN RELATION TO THE OPERATION AND COLLECTION OF ENTRANCE FEE IN THE DINGRAS MULTI-PURPOSE BUILDING (ESCODA MEMORIAL HALL).

WHEREAS, Sec. 22(c) of the Local Government Code defines the power of the Sangguniang Bayan to legalize the authority of the Local Chief Executive to enter into whatever contract concerning the local government unit;



WHEREAS, it is imperative that the municipality will allow PGIN to recover the amount contributed for the rehabilitation, improvement, and development of the said facility through the collection of entrance fee in the Dingras Multi-Purpose Building;

WHEREAS, the Municipality of Dingras, Ilocos Norte is responsible for the appointment of a collecting agent for the collection of the entrance fee and also for its proper maintenance;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


