

**WHEREAS**, the improvement of access road going to and from a tourist destination considered is a vital factor for the promotion of tourism development;

**WHEREAS**, the Madongan Rivermount Resort, located at Barangay San Marcelino, Dingras, Ilocos Norte, is one of the tourist destinations of Ilocos Norte;
