A RESOLUTION RESPECTFULLY AND EARNESTLY REQUESTING HON. ROGELIO SINGSON, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, TO ALLOCATE THE AMOUNT OF FIFTEEN MILLION PESOS (PHP 15,000,000.00) FOR THE CONCRETING OF PURUGANAN-SULQUIANO ROAD LEADING TO A TOURIST DESTINATION, AN ECOLOGICAL PARK AT BARANGAY SULQUIANO, DINGRAS, ILOCOS NORTE.

WHEREAS, one of the development thrusts and goals of the Municipal Government of Dingras, Ilocos Norte is to promote tourism productiveness in the Municipality, and to make it as one of the competitive tourism destination of Ilocos Norte;

WHEREAS, the improvement of the access road going to and from a tourist destination is considered a vital factor for the promotion of tourism development;

WHEREAS, the development and promotion of the ecological Park at Barangay Sulquiano offers a lot of potential to become one of the eco-tourism destination in the Province, provided that the same will be properly developed and improved;

WHEREAS, the immediate concern for the development and promotion of the ecological park is the concreting of the access road going to and from the said place, in order to offer a much convenient access road for the tourists;

WHEREAS, the Municipality has no sufficient fund for the improvement of the access road hence, there is need to seek for the support and consideration of the national government;


