A RESOLUTION AUTHORIZING THE HONORABLE MAYOR ERDIO E. VALENZUELA TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE NO. 1 REPRESENTED BY DR. VALENTINO C. PERDIDO, OIC-REGIONAL EXECUTIVE DIRECTOR, PERTAINING TO THE TRANSFER OF FUNDS FOR THE THREE PROJECTS UNDER THE BOTTOMS-UP BUDGETING (BUB) 2016 COVERING THE REHABILITATION/IMPROVEMENT OF SLAUGHTERHOUSE AMOUNTING TO SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P7,200,000.00); CONSTRUCTION OF MULTI-PURPOSE DRYING PAVEMENT (MPDP) AMOUNTING TO ONE MILLION TWO HUNDRED THOUSAND (P1,200,000.00); AND THE PROVISION OF IRRIGATION FACILITIES/EQUIPMENT, SHALLOW TUBEWELL (WATER PUMPS) AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00)




- a. Rehabilitation/improvement of Slaughterhouse amounting to P7,200,000.00
- b. Construction of Multi-Purpose Drying Pavement amounting to P1,200,000.00
- c. Provision of irrigation facilities/equipment, shallow tube well (water pumps) amounting to P500,000.00

WHEREFORE, on motion of Hon. Joey S. Apostol duly seconded by Hon. Ruben C. Marcos, it was

RESOLVED, as it is hereby resolved to authorize the Honorable Mayor Erdio E. Valenzuela to enter into a Memorandum Of Agreement for and in behalf of the Municipality Of Dingras, Ilocos Norte with the Department Of Agriculture – Regional Field Office No. 1 represented by Dr. Valentino C. Perdido, OIC-Regional Executive Director, pertaining to the transfer of funds for the three projects under the Bottoms-up Budgeting (BUB) 2016 covering the rehabilitation/improvement of slaughterhouse amounting to Seven Million Two Hundred Thousand Pesos (P7,200,000.00); construction of multi-purpose drying pavement (MPDP) amounting to One Million Two Hundred Thousand (P1,200,000.00); and the provision of irrigation facilities/equipment, shallow tubewell (water pumps) amounting to Five Hundred Thousand Pesos (P500,000.00)

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.


